

THIS IS A THREE-YEAR CAREER DEVELOPMENT GRANT OF \$150,000 TO OUTSTANDING YOUNG VASCULAR SURGEON-SCIENTISTS WHO COMBINE THEIR CLINICAL PRACTICE WITH INNOVATIVE RESEARCH. ONE AWARD IS GIVEN PER YEAR, AND 20 GRANTS HAVE BEEN AWARDED SINCE 1996; RESEARCH SUPPORTED BY THIS GRANT ALLOWS THEM TO COMPETE FOR FURTHER FUNDING FROM GOVERNMENT AND OTHER ORGANIZATIONS - AND RESULTS HAVE BEEN EXTRAORDINARY.
